There are two considerations for reservation of your 2019 April tables: You must be a current 2022 or greater member and must pay for the tables by December 15, 2022. may apply for tables, but there is no guarantee of securing a previous table location. We are comfortable to write there will be tables for all, even though the pandemic has altered our original successful plans.

Our Show has a long history of being a Show that caters to an international and national attendance. We are not a local-only happening. Airlines are back in motion which will make our event accessible. Visitors come from far and wide to participate



in this event. We have negotiated a reduced, special rate for our visitors with the Valley River Inn. It is best to phone the Eugene facility for reservations and the reduced rate. Other call services to make reservations doesn't work for the group rates we have arranged. Phone (541)743-1000 and mention the Oregon Knife Show.

Those who have supported us with membership these last few years are to be thanked. This has been what has kept our spirits alive. That, in addition to some healthy unsolicited donations, makes this organization one that will endure. 

# An Alaskan Fishing Knife

This is a true story about a knife that was used by some of the commercial fishermen operating in the waters of Alaska, as I witnessed first hand in 2007. It's quite a large folding knife with a closed length of 5-7/8" and opens to an overall length of 10-5/8". The handle is perfectly round at the blade pivot point and is 1" in diameter. The accompanying three photos show the features of this






cutlery piece as I will further describe herein. The handle is constructed of a single piece of hard, synthetic, rubbery material with checkering to provide a good grip. The handle is bulbed out at the butt and has a hole for attaching a security cord. There is no back spring, but the rubberoid mountings are tight enough that it requires three to four pounds of pull to open the blade. This can be done without using the nail nick with dry fingers and a dry blade, but I'm sure with slippery, wet fingers use of the nail nick is absolutely imperative. The blade is flat ground and its back has a crisscross stamping that may be intended as a scaler or perhaps just for decorative purposes. The knife handle, in protruding print, is labeled Twistmaster for obvious reasons. The circular metal collar (bolster) can be rotated when the blade is fully by using open the protruding rivet heads. The metal collar faces have a slight taper each

side of the open slot. Thus, by rotating the collar either direction, the blade becomes fully locked.

In tiny print on the handle above Twistmaster are the words "by COLD STEEI." By researching this company on my wife's smart phone, I found the following information:

The founder and president of Cold Steel Company was Lynn C. Thompson, who started the company in California in 1980. This company was most noted for the manufacture of commercial, high quality, fixed blade fillet knives, boning



knives, chef knives and butcher knives. The California cutlery operation was shut down after 40 years of operation, and all Cold Steel employees lost their jobs on December 04, 2020, when Lynn Thompson sold the company to the American conglomerate GMS (Good Sportsman Marketing, LLC). GMS is headquartered in Irving, Texas; and currently their Cold Steel products are manufactured in many countries including USA, Japan, China, Taiwan, India, Italy and South Africa. Their products now include hunting knives, survival knives, swords, tomahawks and machetes.



# What Is Knife Engineering?

I recently read a 400+ page book entitled *Knife Engineering, Steel, Heat Treating, and Geometry* by Dr. Larrin Thomas. This book is very technical and detailed, but I found it quite interesting and informative. I want to share a few concepts from Dr. Thomas.

If you are a knifemaker then you have learned that there are many variables that affect the end properties of a knife. The knifemaker has a starting point for their design by considering the best choice of steel that suits the purpose of the knife being made. Next, we consider the variables of edge geometry and heat treatment/ tempering decisions to optimize performance.


If a knife has poor corrosion resistance, blade chipping, edge deformation or poor cutting ability, we need to find ways to change or improve these failures. The variables of steel choice, edge geometry and heat treatment allow the maker to change the design until the preferred combination of properties are achieved. And that my friends is knife engineering.

One of the key concerns of a knife buyer is edge retention, which is the ability of a knife to maintain its sharpness as it is used for cutting. Higher hardness in the blade steel usually means better resistance to deformation and rolling of the blade edge. Higher toughness means better resistance to chipping, fracture or breakage. Powdered metal steel tends to have finer carbides which show higher toughness.

If the task for the blade is primarily slicing, an edge sharpened with a coarser grit generally works better because of a more "saw tooth" behavior that reduces the force required to slice. A blade designed for push cutting, such as the whittling of wood. performs better with a more polished edge. For chopping knives, the cut is most like a push cut; so a polished edge is preferred. Coarse edges have easier crack initiation which can lead to chipping.

When using a knife in saltwater or if cutting acidic materials, the loss of edge retention or dulling of the edge is caused mainly by corrosion. When cutting abrasive material like rope, it is likely to be wear that dulls the edge. When chopping hard materials, it is likely to be rolling or chipping which dulls the edge. A more acute edge angle increases cutting ability but can also lead to rolling or chipping of the edge.

So, have you figured out the best knife steel? Even if there was a best steel, it would only be as good as the combination of blade geometry, proper heat treatment and proper tempering of the steel selected.



#### ALL EXHIBITORS are required to keep their tables set up throughout the public hours of the Show: 8 AM Saturday to 3 PM Sunday. ANY EXHIBITOR WHO LEAVES OR COV-ERS THEIR TABLE BEFORE 3 PM SUNDAY FORFEITS FUTURE RESERVATIONS AND WILL BE DENIED TABLES AT FUTURE OREGON KNIFE SHOWS.

**DISPLAY TABLES** will be around the perimeter of the room. Displays are eligible for display awards, which are hand-made knives donated by members and supporters of OKCA. Display judging will be by rules established by OKCA. Special category awards may also be offered. NOTHING MAY BE SOLD FROM DISPLAY TABLES.

SALE/TRADE TABLES Sharing of tables will not be allowed. Exhibitors must comply with all applicable local, state, and federal laws. Oregon has NO SALES TAX.

KNIFEMAKERS who are present and are table-holders at this Show may enter knives in the knifemaking award competition.

SHOW FACILITATORS will be provided by OKCA from 10AM Friday until 4 PM Sunday. However, exhibitors are responsible for watching their own tables. Neither the OKCA nor the Lane Events Center will be responsible for any loss, theft, damage, or injury of any kind.

### CITY AND COUNTY REGULATIONS require that there be:

- No Smoking within the Exhibit Hall at any time;
- No alcoholic beverages consumed within the
- Exhibit Hall during the public hours of the Show;
- No loaded firearms worn or displayed at the Show;
- No swords or knives brandished or displayed in a provocative manner.

**NOTE ON SWITCHBLADES AND DAGGERS:** In Oregon it is legal to make, sell, buy, or own switchblade knives. However, it is *ILLEGAL* to carry a switchblade knife, a gravity knife, a dagger, or a dirk concealed on one's person, or for a convicted felon to possess a switchblade or gravity knife. Most other states have banned switchblade knives. Under federal law, it is *ILLEGAL* to mail, carry, or ship a switchblade or gravity knife across state lines.

The Oregon Knife Collectors Association is not responsible for force majeure.

# Elk and Deer Antler Handles II

By now all the good folks out in knifemaking land, at least the Oregon part, have purchased the Oregon Department of Fish and Wildlife, Hide/ Antler Dealer License. It is now possible for them to legally purchase deer and elk antlers to cut up for use in handcrafting items. The applicable law and the procedure for obtaining a license were explained in part #1, which was in last month's *Knewslettter*.

You have just purchased your first antler, which was one side of a large elk antler. This was a shed antler and was so listed by size and type in the record book that is required to be kept by those with a license to purchase and use antler. This was a Roosevelt elk antler, which was determined by the shape of the button or crown. Roosevelt elk have a button that is fairly round; the Rocky Mountain Elk button is somewhat of a slight teardrop shape. In the photo, (A) is from a small Rocky Mountain Elk, (B) is from a Roosevelt Elk and (C) is from a Sambar Stag. The Roosevelt Elk are usually found in the Cascade Mountains and west to the coast. I figure they prefer the wet conditions. The Rocky Mountain Elk is found in the dry, eastern part of our state, and on east throughout the Rocky M o u n t a i n s . Sambar Stag, if you found a complete antler in Oregon, would be exempt from the law because it is not an Oregon game animal.


Living Sambar stags are usually found in India, Australia and New Zealand. In my research I found a guided hunt in New Zealand for Sambar Stag. With a price tag of \$8,000.00, I decided not to hunt for Sambar handle material. I'll just keep paying the going price from the knifemaker supply companies.

Can you legally sell antler-handled knives in California? Only if it is from a shed antler, according to a conversation I had with an official of the California Department of Fish and Game. Furthermore, I was told that my knives made with parts of legally purchased antlers from Oregon game animals would be subject to the same law if they were being offered for sale in California. If you think not, you haven't heard about the knives confiscated at the Great Western Show some time back.

See the photo of the elk antler. This was

a medium sized antler that was heavy enough to indicate a thick wall. The same sized antler might weigh half what this one does and have material that was too thin to make anything other than small slabs folder or be used for miniatures.

The photo shows the lines that mark where I would make the first cuts. Use a lead

There will always be lots of small scrap pieces from cutting antlers, some of it very beautiful. I'm planning on making some mosaic type handles in order to use up the small pieces of real fine antler and stag. They are not good for much except button material
